



FUND OBJECTIVE

The Fund aims to provide long-term capital growth using a global top-down thematic approach. Investments are identified based on their ability to advance technological innovation and change consumer behaviour. It targets an annual return* of US Consumer Price Inflation plus 7% over any rolling seven-year period.

INVESTOR SUITABILITY

The Fund is suitable for retail and institutional investors seeking higher long-term returns while being able to endure periods of elevated volatility. It is not suitable for investors seeking capital preservation or those with a short timeframe. An investment horizon of 7+ years is recommended.

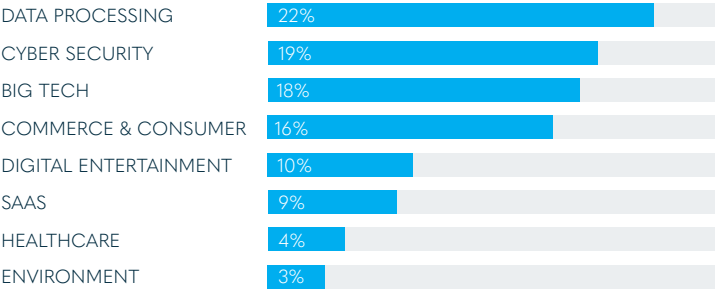

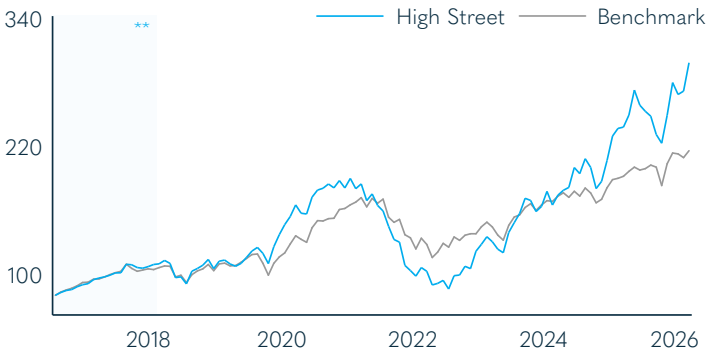

QUARTERLY COMMENTARY AS AT 30 JUNE 2026

The second quarter of 2026 delivered a powerful reversal in market dynamics, as the geopolitical anxieties and corrective price action that defined the start of the year gave way to one of the strongest quarterly advances of this century. The primary catalyst for this shift was a significant easing of the U.S.-Iran conflict, culminating in a formal agreement on June 18 to reopen the Strait of Hormuz. This diplomatic breakthrough triggered a sharp unwind of the Q1 energy risk premium, with Brent crude oil plunging roughly 20% in both April and May to fully reverse its war rally and return to pre-crisis levels near the low \$70s.

This dramatic collapse in energy prices provided a dual benefit to global markets: it significantly alleviated near-term stagflation anxieties and supported robust underlying economic resilience. Fuelled by accelerating corporate earnings, expanding margins, and an infrastructure-led "AI frenzy," the S&P 500 and Nasdaq-100 recorded their best quarterly performances since Q2 2020, rising 15.3% and 21.6% respectively.

In the quarter, the Fund returned 20.7%, outperforming the benchmark (Morningstar EAA Fund Global Large-Cap Growth Equity category) which returned 16.1%. Performance was driven by semiconductor and hardware infrastructure companies, which soared as hyperscale capital expenditure and structural demand for advanced memory chips accelerated. This trend was underscored by the Philadelphia Semiconductor Index (SOX), which rose 87.8% to mark its best quarterly performance since its inception. During the quarter, the Fund exited its position in Visa due to concerns about future growth rates.

For the month of June, the Fund returned -4.0% relative to the benchmark return of -0.41%, driven by a broad-based reversal in the Fund's largest-weighted growth exposures, with Big Tech, SaaS and Digital Entertainment mostly retracing as the market paused to reassess near-term AI monetisation timelines. This was partly offset by continued strength in Cybersecurity and resilience in Semiconductors.

Highlights within the Fund's eight themes during the quarter were as follows:

- **Semiconductors:** Drove the majority of outperformance this quarter. Advanced Micro Devices (AMD) was the standout contributor, surging 186% as its data centre server CPU gains and Instinct GPU ramp caught the market's full attention. This strength was mirrored across the entire hardware value chain, with ASML gaining 51%, TSMC jumping 41%, Broadcom advancing 22%, and NVIDIA seeing 15% gain as global compute demand remained relentless.
- **Cybersecurity:** Recovered after a volatile Q1, as the market got more comfortable with the sustainability of business models in an AI-driven world. Palo Alto Networks (+113%) and CrowdStrike (+95%) surged as platform consolidation and enterprise security budgets crystallised, while cloud security infrastructure provider Cloudflare gained 19% and Zscaler traded flat (+1%).
- **Big Tech:** The large hyperscalers anchored the fund with highly visible growth. Alphabet (+23%) and Amazon (+14%) posted strong double-digit gains on the back of resilient cloud acceleration, while Microsoft (+1%) lagged the broader rotation to finish effectively flat.
- **Healthcare:** Eli Lilly advanced 30%, continuing to benefit from massive structural demand and expansion of its metabolic pipeline, which comfortably offset a temporary 9% pullback in Alnylam.
- **Environment:** As supply chain security and critical mineral dependencies remained top of mind following the Q1 geopolitical shock, MP Materials rebounded 16%, reflecting the inherent operational leverage embedded in its asset base.
- **Commerce & Consumer:** Underperformed as Uber finished flat (0%), while Mercado Libre (-2%) and Shopify (-4%) saw minor pullbacks. Automated warehouse supply chain player Symbotic fell 16% despite continuing to advance its margin profile.
- **Software-as-a-Service:** Enterprise software platforms continued to experience valuation pressure during the quarter. ServiceNow declined 5%, while Adobe (-16%) and Salesforce (-16%) pulled back materially as the market reassessed the near-term monetisation timelines of application-layer AI.
- **Digital Entertainment:** Media consumption properties faced tough multi-year comparisons and profit-taking. Meta Platforms drifted down a modest 2% and Spotify fell 5%, while Netflix tumbled 26% as the market focused on content delivery schedules despite recent surges in subscriber growth.

Despite significant share price volatility, the underlying operating performance of our holdings continues to reinforce our long-term positioning. Across the Fund, 96% of holdings beat consensus revenue expectations for the period, while 68% exceeded EPS estimates. Forward guidance updates also continued to highlight the apparent durability of structural investment. Broadcom, for example, guided for a massive acceleration in custom AI accelerators next quarter, with AI semi revenue expected to grow over 200% year-over-year.

Looking ahead, the macro environment continues to paint a complex picture, as newly-appointed Federal Reserve Chairman, Kevin Warsh, attempts to counter sticky underlying core PCE inflation, which rose to 3.4% in May. Nevertheless, the strong fundamental footing of markets is well-supported by broader corporate strength. The S&P 500 is anticipated to deliver robust results across both top- and bottom-lines for Q2 2026. According to FactSet data, year-over-year Q2 earnings growth expectations have climbed significantly throughout the quarter, rising from +18.8% at the end of Q1 to 23.1%. Top-line expectations are trending higher in tandem, with Q2 revenue growth forecasts accelerating from 9.5% to 12.3%. This powerful pairing of accelerating revenue growth alongside a sharper increase in EPS growth implies continued margin expansion, matching the broader trend we have monitored over the past several quarters.

To manage absolute risk and optimise capital towards names with unappreciated fundamental strength, we continue to selectively trim positions within the Fund where rapid price appreciation has concentrated individual stock weights. Despite outsized moves, the underlying operational engines of the businesses we own, defined by robust revenue growth, premium returns on invested capital, and secure balance sheets, reaffirm our long-term conviction.

WHY IS THIS FUND IN CATEGORY 6?

The Fund is rated as 6 due to exposure to high-growth shares and stocks, and the nature of its investments. WHAT DO THESE NUMBERS MEAN?
